
This first issue summarizes the Excellence in Academic Advising (EAA) initiative and its relationship to JHU, describes the four implementation groups that are part of this initiative, and highlights one of the most important accomplishments of EAA thus far-the creation of an academic advising mission statement that defines what academic advising is, aligns it with the educational values of JHU, and identifies key learning outcomes for our undergraduate advising practice.

What is EAA?

During the 2018-2019 academic year, Johns Hopkins University became one of the first institutions to participate in the Excellence in Academic Advising (EAA) project sponsored by NACADA: The Global Community for Academic Advising and the Gardner Institute. The EAA initiative is an opportunity for participating institutions to do a "deep dive" into their school's academic advising practices for the purposes of reflection and enhancement. The initiative is structured into two phases: Phase 1 was data collection and recommendations; Phase 2 is the implementation of the

recommendations. While the assessment in Phase 1 focused specifically on the Homewood schools, Phase 2 will incorporate the Peabody Conservatory to better meet the needs of all undergraduate advising programs and students at JHU.

In Phase 1 working groups formed around <u>Nine Conditions of Excellence in</u> <u>Academic Advising</u> and engaged in a comprehensive, evidence-based analysis of current JHU advising practice and offered specific recommendations for improvement going forward. A <u>Final Report</u> summarizing the findings of Phase 1 was released in November 2020. It identifies four key areas for revision: *1) Mission Statement and Learning Outcomes, 2) Advising Structure, Roles, Performance, and Equity, 3) Advising Technology,* and *4) Advisor Training and Professional Development.* Four implementation groups have been proposed to develop action plans for each area during Phase 2 of the project. **Click on the image below to learn more about committee goals, membership, and progress.**

Under the leadership of Dr. Katie Henry and in collaboration with faculty and staff from Krieger, Whiting, and Peabody, the Mission and Learning Outcomes EAA working group created a new and shared mission and learning outcomes for undergraduate advising at JHU.
